EPAMAP provides after-school programs and employment opportunities to at-risk youth, including a 14-week mural program in which teens research, develop, design and install a public art project.

This past year, we were also pleased to announce the appointment of René Kathawala to the newly created post of Pro Bono Counsel—a move that reflects the firm's deep commitment to community responsibility. A former Orrick associate, René returned to the New York office following a U.S. District Court judicial clerkship to manage and coordinate pro bono matters firmwide. In his new role, René will work closely with team members in Orrick's 16 worldwide offices to maximize the reach and impact of our community work.



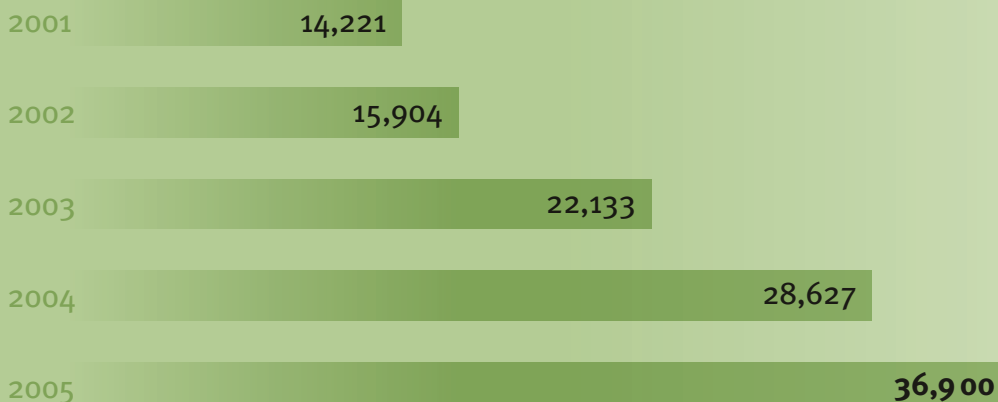

Our commitment to serve the community through pro bono legal services, volunteer time and financial support grows stronger each year. It has become a core tenet of the way we work—and live—and is reflected in the character of each person at the firm.

Our goal is to utilize our knowledge, talent and energy, as well as our financial resources, to support those who could not otherwise afford legal representation. We recognize that work on a pro bono matter often requires a significant amount of time and can sometimes stretch over many years. In 2005, Orrick proudly dedicated more than 36,900 hours of attorney and paralegal time to support its Community Responsibility initiatives—a 150% increase over our commitment just five years ago.

In a unique partnership formed in 2003 with the YMCA of San Francisco, Orrick supports this vital year round after-school program both financially and through volunteerism.

Future Leadership and Access to Justice in Harlem

The Children's Storefront is a forty-year old independent, tuition-free school based in Harlem that serves preschoolers through eighth graders. Orrick's support of the nonprofit began in 2003 and has steadily expanded. Orrick attorneys staff a weekly hotline providing parents and faculty with access to legal advice. Orrick volunteers also meet with students on a weekly basis to provide homework assistance and tutorials, and the "Birthday books" are another cherished tradition by all. Orrick managing director John MacKerron serves on the board of directors for The Children's Storefront, and more than 50 attorneys and staff volunteered their time in 2005.

Helping Healthy Children Enjoy Their Right To Play

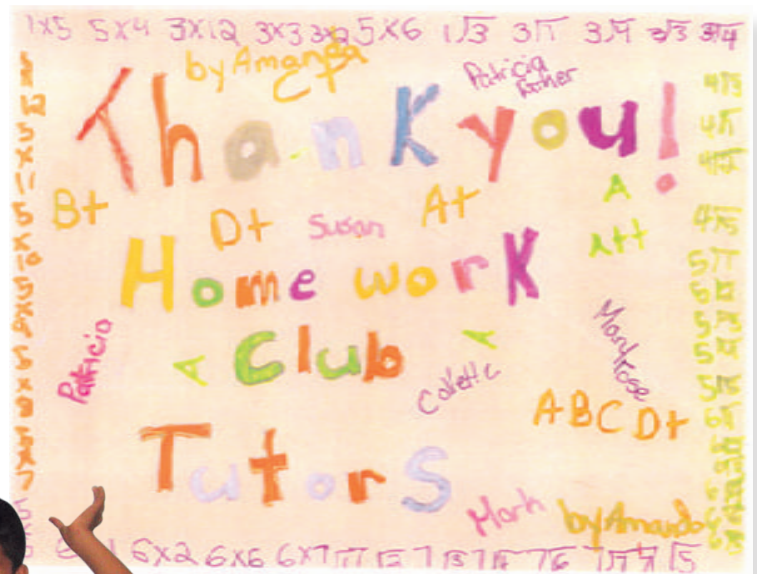
Orrick's involvement with Toronto-based Right To Play, an international humanitarian organization that uses sports and play to foster the development of children, is truly a team effort. Leading the undertaking is London-based partner Carl Liederman, who serves on the organization's Team USA advisory board. In the past year alone, Orrick has provided more than 730 hours of pro bono time to the nonprofit. Legal guidance in areas ranging from corporate, tax and IP to employment, contracts and partnerships has helped Right To Play continue to thrive and reach thousands of disadvantaged children. Right To Play is supported by the International Olympic Committee, the UN, UNICEF, World Health Organization and 200+ athlete ambassadors, including Matthew Pinset, Lance Armstrong and Wayne Gretsky.

Technology Takes on a New Generation

As a major user of advanced technology—including hundreds of laptops and desktop computers—Orrick wanted to find a way to put its technology investments to good use. This past year, the firm initiated an IT donation program to help educational groups. Schools receiving the equipment have found a variety of ways to put it to use, from equipping their computer labs and supplementing office networks to providing vocational and computer science classes with devices that can be studied, rebuilt and refurbished.



Rising Above Raises Record Funds

Orrick lawyers and staff celebrated their third year supporting Students Rising Above with their best ever charity auction raising more than \$36,000 and involving more than 120 Orrick team members firmwide. For the auction, Lynne Hermle collected vacation homes in exotic locales, gourmet dinners, private poker lessons, and even bobble-heads in the likeness of firm leaders from generous Orrick lawyers and staff in Silicon Valley, San Francisco, New York, Los Angeles, London and Paris.

Established in 1998 by Bay Area news anchor Wendy Tokuda, Students Rising Above is dedicated to helping high school students throughout the Bay Area overcome great odds to pursue their education—and their dreams. Many of the students benefiting from the organization's efforts include homeless teenagers.

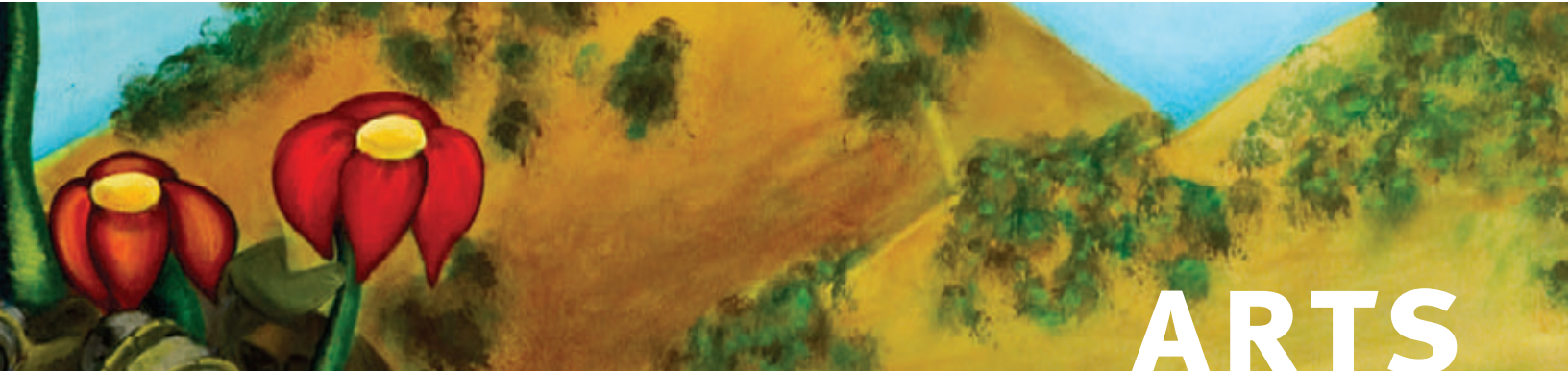
A New Relationship

Orrick's Sacramento office adopted Oak Ridge Elementary School, a K-6 public school with approximately 500 students, most of whom are from families living below the poverty line. Upon hearing that a majority of Oak Ridge students could not afford to purchase \$7 uniform shirts, a committee which included director of government affairs Jim Bruner, partners Jenna Magan, John Myers and Julie Totten, of counsel Peg Toledo, associates Stacy Don and Alex Sperry, office administrator Betty Neil, project manager Melissa Warr, legal secretary Jeanette Ponce and document specialist Leslie Thomson, led the effort to establish a Uniform Scholarship Fund. To express support for teachers and staff, the office hosted first day of school and holiday breakfasts, and presented each classroom with a globe. The committee continues to explore ideas for future school projects, including campus improvement, after-school programs, teacher-morale initiatives and field trips.

A Brighter Day for Young Orphans

Attorneys and staff from the Beijing office of Coudert Brothers that is transitioning to Orrick, together with Orrick's Hong Kong office, pooled their energy and resources to support an orphanage in Tianjin. From gifts for the children to the donation of a computer and monitor for the orphanage office, the outreach helped in immeasurable ways.

On the Road with the San Francisco Opera

Orrick's continued support of the San Francisco Opera's education programs helped bring the magical sounds and scenes of the opera to more than 35,000 Bay Area school children last year. Dubbed Opera à la Carte, the organization's outreach program helps enhance young students' understanding of all aspects of opera. Bay Area students work directly with professional singers, pianists and volunteers to rehearse—and then perform—a mini version of a featured performance. This year's billing, *Pirates of Penzance*, was a smash hit. Orrick's commitment to this important cultural organization also includes the involvement of Marybeth La Motte, the firm's Community Responsibility Program manager, who raised over \$200,000 for the opera in 2005 as the spring gala chairwoman, and serves on the board of directors for the San Francisco Opera Guild.

California Council on Humanities Honors Orrick

The California Council for the Humanities presented an Award of Recognition to Orrick in gratitude of the firm's generous pro bono legal services over the past three years.

A state affiliate of the National Endowment for Humanities, the California Council for the Humanities' goal is to enrich California's cultural life through the creation and support of programs focused on the region's history and culture. This past year, its California Stories Uncovered program brought people across the state together to share and listen to stories that delved beyond the headlines, statistics and stereotypes that have come to define California and its diverse population.

The nonprofit group grants wishes for children and their families, allowing them experiences—and memories—to be cherished. More than 1,250 attended the Rays of Sunshine event, with ill children arriving in coaches from 17 hospitals in and around London.

PRO BONO LEGAL SERVICES



Martin Luther King said it best—“Injustice anywhere is a threat to justice everywhere.” From financial devastation to human rights abuses to government oppression, there are a growing number hardships that put justice just out of reach for so many today. Orrick is committed—and proud—to provide blue-chip legal services to those most in need.

HELPING OTHERS AROUND THE WORLD

One of the focuses of Orrick’s pro bono legal services has been to assist individuals with their immigration law needs. We achieved many significant victories for our deserving clients, including:

- ▶ Through the Lawyers Committee for Civil Rights, litigation associate Rocky Tsai led a team that assisted a Russian immigrant held in custody by the Department of Homeland Security for more than 16 months. Now the former boxer calls San Francisco home thanks to Tsai, partner George Yuhas, associates Cathy Lui, Thomas Harvey and Leah Scholer.
- ▶ In New York, IP associate Rodger Sadler successfully represented a mother and son in a permanent residency hearing pursuant to the Violence Against Women’s Act (VAWA). Earlier in the year, Orrick helped a mother of three children of Mexican origin obtain permanent U.S. residency based on VAWA . Both cases were referred to Orrick by Sanctuary for Families, an organization that helps immigrant women leave abusive spouses. VAWA was passed by Congress to give immigrant women a way to leave abusive relationships without risking their immigration status.



Local Loans Make the World of Difference

Orrick continued its pro bono representation of Global Partnerships, a Seattle-based nonprofit, helping to establish a \$1.8 million microfinance credit fund aimed at alleviating poverty in Central America. This unique initiative bridged the widening gap between Wall Street and traditional philanthropy and represents a new wave of creative financing initiatives.

By creating an independent entity wholly owned by Global Partnerships, the new organization expects that the funding raised from socially-motivated investors will result in more than 15,000 loans to the working poor in Nicaragua, Honduras, El Salvador and Guatemala.

The Orrick team, led by Seattle corporate partner Alan Smith, included New York global finance partner Mary Rose Brusewitz, San Francisco tax partner Steve Malvey and Seattle corporate associate Makambo Tshionyi. They were assisted by New York global finance associate Adam Gehrie, Washington, D.C. global finance associate Evan Williams, Seattle public finance associate Ben Juergens, San Francisco corporate associate Virginia Percy, New York global finance associate Bridget Kurt DeJong and Seattle corporate legal assistant Patrick Finn.



- ▶ San Francisco associates Leah Scholer and Armen Zohrabian represented a Guatemalan woman who fled her country for protection against her abusive husband. The Orrick team received the case from the Lawyers Committee for Civil Rights just a few weeks before the first hearing. The woman was granted asylum—and the right to bring her two young children to live with her in the United States.
- ▶ New York Associates James McQuade, Eileen O'Connor and Silicon Valley associate Sid Venkatesan won political asylum for a Buddhist monk from Tibet who was arrested for expressing his views in favor of Tibetan independence from China. The case was referred to Orrick by Human Rights First, a legal services organization dedicated to defending human rights worldwide.

- ▶ Washington, D.C. associate Reagan Beck, with supervision by partner Adam Goldberg, provided assistance on behalf of the Catholic Legal Immigration Network, Inc. in an immigration appeal for a mentally ill defendant. The Board of Immigration Appeals affirmed the lower court's decision favorable to our client.
- ▶ Orrick partner Sam Scott Miller visited India as part of a delegation sent by the Committee on International Human Rights of the Association of the Bar of the City of New York. The group's mission—to assess the implications of India's response to terrorist threats and, if needed, provide recommendations for strengthening efforts.



Read On—Orrick Helps Local Bookstore Reopen

Kepler's Books and Magazines, one of the oldest and most successful independent bookstores in the country, is recognized as an important launching pad for Bay Area-based authors. All that was coming to an end, however, as Kepler's grappled with a huge monthly rent bill.

Within hours of sending an email to locals about the store's closing, the former Mayor of Menlo Park, California received commitments of \$50,000 in private financing. When Orrick associate Daniel Yost (a frequent Kepler shopper) received word of the store's closing, he quickly offered his support via pro bono legal services. With Yost in the lead, Orrick represented a group of private investors—including local business leaders, venture capitalists and the son of the store's original owner, Roy Kepler—to finalize the deal terms. Happily, Kepler's has reopened and is now on solid footing to begin its next 50 years in the book business. Other lawyers from Orrick's emerging-companies group that negotiated the deal were Donald Keller, Jennifer Mar, Christine Tomomatsu and Mitchell Zuklie.

Personal Injury—and International Injustice—Resolved

Sergey Milanov, an Orrick litigation attorney in Tokyo, successfully represented a Japanese widow whose husband was electrocuted while traveling in Russia on a biology research expedition. When Sergey filed claims for negligence against a power line operator, the odds of collecting damages were slim—as they always are in Russia.

Orrick was brought into the case by the Japanese Consul in Yuzhno-Sakhalinsk. Together with its co-counsel in Russia, the Orrick team helped obtain a favorable decision against the cable owner. The decision was appealed, and then when upheld, payment was withheld. The determination of the Orrick team never wavered—with full payment finally remitted to our client.

One Economy—Equal Access for All

A team of lawyers led by Silicon Valley corporate partner Scott Elliott and IP associate Joshua Walker assisted One Economy, a nonprofit dedicated to bringing broadband, education, information and asset-building tools to low-income families. Orrick's initial work focused on various transactional matters, as well as an IP assessment of the group's "beehive" website that provides low-income families with ready, online access to advice concerning health, finance and other information. One Economy was introduced to Orrick through Cisco System's charitable foundation.

Helping Those with Disabilities

In San Francisco, Bill Alderman and Leah Scholer collaborated to support the Disability Rights Education & Defense Fund, a group dedicated to improving access policies and training, to ensure proper accommodations for people with disabilities.



AWARDS



CORNERSTONE AWARD

Stephen Millas, an associate in the firm's real estate practice received the "Cornerstone Award" from Lawyers Alliance for New York. Presented annually, the award recognizes the outstanding pro bono legal service provided to nonprofits by business lawyers in New York. The 2005 Cornerstone Award marks the third time an Orrick attorney has been named with the honor. The 2001 recipient, René Kathawala, recently returned to Orrick as the firm's dedicated pro bono counsel. The firm was also presented with the Cornerstone Award in 1997.

EXTERNS HONORED

Orrick was honored this year by the New York Legal Aid Society. The award was presented to three Orrick associates who participated in the firm's externship program, which enables attorneys to dedicate themselves full-time to pro bono service while employed by Orrick. Bridget Kurt DeJong, Jonathan Melber, and Renee Phillips were honored for their service.

As part of the firm's externship program with Lawyers Alliance for New York in 2006, three Orrick associates—Susannah Lipsyte, Elizabeth Watson and Adam Zimmerman—will serve a four-month externship, dedicating themselves full-time to assisting nonprofits on a wide variety of legal issues.



NEW YORK LEGAL ASSISTANCE GROUP

Orrick was presented with the Special Honoree award for its pro bono service and support of the New York Legal Assistance Group (NYLAG), a nonprofit legal services organization that provides free legal assistance to New York's at-risk, low-income populations. In addition to supporting NYLAG with pro bono legal services, Orrick also funds two Equal Justice Works Fellowship programs for the organization. Jill Rosenberg, Partner in Charge of Pro Bono Programs, serves on the board of NYLAG. Chief Judge Judith Kaye from New York State's highest court, the New York Court of Appeals, was the guest speaker at the award ceremony.

UNSUNG HERO

Neel Chatterjee from Orrick Silicon Valley was named an "Unsung Hero" by the Minority Access Committee of the Santa Clara County Bar Association. The annual award recognizes individuals and organizations who are leaders or mentors in their communities.

COMMUNITY PARTNER AWARD

Project Open Hand recognized Orrick with its 2005 Community Partner Award. The honor was given in recognition of Tim Johnson, Orrick's Silicon Valley office operations manager, who worked for more than two years to assemble and present the 20-year oral history of Project Open Hand.

ORRICK RESPONDS

The catastrophic events of 2005 had a profound impact on millions around the world. Without hesitation, businesses and individuals alike, found ways to assist financially and through volunteer efforts. In recognition of all those at Orrick who were able to make financial contributions to help others overcome, the firm created a matching funds program.



Three major events—the Indian Ocean Tsunami, the earthquake in Pakistan and Hurricane Katrina—displaced millions from their homes and devastated their communities.

Indian Ocean Tsunami

Orrick attorneys and staff from around the world made a contribution of \$150,000 to help the victims most affected by the Indian Ocean Tsunami get medical attention—then begin to rebuild their lives.

The children of the Orrick Year-Round Enrichment Program at the Bessie Carmichael Elementary School found a way to help as well. The youngsters held a bake sale—complete with cupcakes and other home-made treats—at Orrick's San Francisco office to raise funds for the victims.





Kashmir Earthquake Relief

Orrick's efforts focused on helping to provide emergency relief and long-term reconstruction assistance. With the earthquake striking just prior to winter, many in the area were left homeless in isolated mountain villages. European office leader David Syed reacted quickly and established the Association for Assistance to Earthquake Victims in Pakistan. Orrick funds supported volunteer workers in the Kaghan Valley, including the purchase of tents and supplies for mountain guides, doctors and para-medical staff from Peshawar. David's sister, Jasmin Syed, labored with the volunteers onsite and ensured that the essential equipment reached the volunteers.

Hurricane Katrina— Orrick Unites and Delivers \$250,000 and More...

Support for the victims of Katrina was swift and widespread. In addition to the \$250,000 in contributions made by the firm and its employees, Orrick provided legal representation to the City of New Orleans on a significantly reduced basis, in an audit conducted by the Internal Revenue Service examining bonds issued by the city. The Orrick team was engaged after a preliminary adverse determination was issued, and played an instrumental part in taking the issue to the IRS Appeals Office, a process that has included extensive meetings and negotiations with key officials.

Assistance from Orrick's Paris office came in a different form. There our focus was on helping 360 Parisian school children as they reached out to children and families in New Orleans. We underwrote the cost to ship toys and artwork to families of New Orleans firefighters, and also made a financial donation to the firefighters on behalf of the young Parisian students.

► *Food and safe shelter are two basics that remain out of reach for thousands of people in neighboring communities. Orrick teams in Los Angeles, San Francisco and Silicon Valley united with established community organizations volunteering countless hours, "elbow grease" and financial resources to help people have a place to call home and the comfort of a warm meal.*



NATIONAL BRAIN TUMOR FOUNDATION

Led by global finance partner Dolph Hellman, Orrick raised more than \$50,000 in honor of former partner Marie Riehle, to benefit the National Brain Tumor Foundation. Marie, together with the foundation's executive director, came to Orrick San Francisco to personally express their gratitude and present the firm with an award of appreciation.



2005 CHARITABLE OUTREACH
